PRE-AUTHORIZED PAYMENT PLANS

Available to those whose accounts are in good standing.

Option I — 10 Month Payment Plan

The first five months are based on the previous year's taxes, with the remainder being based on the current year's taxes. These amounts are automatically withdrawn from your account on the *last working day* of each month (January to October).

Option II — 4 Installment Payment Plan

This option is for those who wish to continue to pay in four installments, but have the payments automatically withdrawn from their bank account. These installments will be withdrawn on the *last working day* of the month in which the installment is due.

CONVENIENT

You'll no longer have to write cheques or stand in line to pay your bills. The payments are always deducted on the last working day of the month, so you'll never have to guess when payment is due and it is automatically recorded on your chequing account system.

SECURE

There are no cheques to get lost or stolen.

ASSURED

Your payments will always be made on time, even if you're out of town or there is a postal disruption. Avoid the embarrassment of missed payments and the cost of penalty charges!

ENROLLING

If you choose the Pre-authorized Tax Payment Plan and if your taxes are paid up to date, please return the attached form along with a void cheque or deposit slip. If you own more than one property in Town, please complete a separate application form for each tax account.

PENALTIES AND CHARGES

If any payment does not clear your bank account, a charge of \$30 will be imposed and a penalty of 1.25% will be added to your account. Your account will be removed from the Pre-authorized Tax Payment Program and revert back to the four installment program.

EASY TO CHANGE

If you change bank accounts, simply notify the Tax Department in writing 30 days in advance and a new agreement will be arranged so your payments can continue without interruption. If any incorrect amount is processed against your account, notify the Tax Department to have it corrected.
