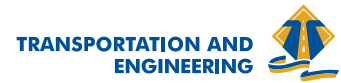

County Road 93 Tree Clearing

The County of Simcoe has awarded the contract to Ultimate Construction Inc. for tree clearing on County Road 93 (CR 93).

The work includes the clearing of trees and brush within the CR 93 right-of-way from St. Andrews Drive to Thompsons Road.

Ultimate Construction Inc. plans to mobilize on **February 25, 2019** and is scheduled to start the tree clearing work on **March 4, 2019**. The tree clearing work is anticipated to be completed by **March 29, 2019**.

Tree Clearing

Ultimate Construction Inc. and R.J Burnside & Associates Limited will be on-site during the week of March 4, 2019 marking trees for removal. Private property lines will be surveyed to ensure that tree clearing is only completed within the CR 93 right-of-way.

Lane Restrictions

During tree clearing operations, traffic speed will be reduced to 60 km/h through the work zone. Construction crews and equipment will be parking and working on the shoulder of the roadway and no travel lane restrictions are anticipated.

Advanced warning signs will be installed on CR 93 along with Vindin Street and Golf Link Road to warn motorists of the activities.

How will I get to My Home/Business?

The Contractor will maintain access to your home/business at all times

Access for emergency vehicles will be maintained at all times.

Will My Services Be Affected?

Telephone, Electrical, Cable TV and Gas services should not be affected by the construction, barring any unforeseen circumstances.

Safety

Tree Clearing involves the use of heavy equipment, noise and the unavoidable creation of obstacles at times.

These circumstances are attractive to children, and we ask that you caution your children to stay clear of the working area.

The contractor is required to conduct the work in a safe manner, and we ask that you take extra caution during the construction period.

Please avoid the work area and do not approach the tree clearing operations to ensure everyone's safety.

We ask for your patience during this time of improvements and thank you for your cooperation.
