TAKE NOTICE that the Council of the Corporation of the Town of Midland will hold a public meeting on **Wednesday October 6th, 2021 at 7:00 p.m.** to hear the planning merits and gather public input regarding a proposed Sign By-law Amendment under Section 8.2.4 of Sign By-law 2011-79.

Pursuant to provincial policies, public attendance at Council meetings is not permitted at this time; however, you may still participate in the public meeting as outlined below. THE PURPOSE AND EFFECT of the proposed Sign By-law Amendment is to permit a Ground Sign indefinitely to demarcate specific parking spaces within the property's parking lot. The applicant has proposed 12 Ground Signs to be installed in parking stalls at this time.

The proposed Sign By-law Amendment pertains to land located on the north side of Highway 12, municipally known as 16845 Highway 12, located in the Town of Midland. The land is presently zoned as Highway Commercial – HC in the Town of Midland Zoning By-law No. 2004-90, as amended.
