### Terms and Conditions

In consideration of receiving the rebate under this Program, the undersigned Applicant acknowledges and agrees:

**1. THAT the Applicant will attach to this application a picture of the toilet being replaced (13 litre volume) as installed in home; and a picture of the new toilet (being 6 litre or less volume) as installed in home to this application in order for approval of replacement rebate.**

2. THAT the Corporation of the Town of Midland is not responsible for the selection, installation or operation of the toilets;

3. THAT the toilet must be a new, water efficient model **6 litres or less** in volume and must be installed in a residence located in the Town of Midland that is connected to the municipal water supply;

4. THAT the Applicant shall provide the Town of Midland or its agent with reasonable access to the toilet, that the Town of Midland or its agent may inspect any residence participating in this Program in order to verify the installation of the water efficient toilet and eligibility of the same, if the Town of Midland so requests, and that the Town of Midland or its agent may access utility billing account information for the purpose of monitoring water and energy consumption;

5. THAT the Town of Midland does not guarantee or warrant the toilet or its installation, the performance, freedom from defects, quality of workmanship or suitability of the toilet or any installation thereof for any purpose, or the suitability of the premises for installation. Further, the Applicant acknowledges and agrees to assume any and all costs of the installation or any alterations necessary for the proper installation of the toilet;

6. TO indemnify, save and hold harmless the Town of Midland, and its agents, officials, officers, councilors and employees (collectively, the agents) against all liability, loss, costs, damages, and expenses, causes of action, actions, claims, demands, lawsuits and other proceedings, by whomever made, sustained, brought or prosecuted, including by third parties, involving bodily injury, death, personal injury, and property damage, in any way based upon, occasioned by or attributable to the Applicant's participation in this Program, including any negligence on the part of the Town of Midland, or its agents; and

7. TO refund such rebate to the Town of Midland on request, if this application contains any material misstatement or misrepresentation on such Applicant's behalf, or if the Applicant breaches any of these terms or conditions.

### Notice of Collection

The personal information on this form is collection pursuant to the Municipal Act and in accordance with the Municipal Freedom of Information and Protection of Privacy Act. This information will be used for the purposes of participation in, and administration of this program, and updates about water conservation initiatives.
