## **BY-LAW 2025-56**

A By-law to amend Zoning By-law 2004-90, as amended, for the lands municipally known as 736 King Street in the Town of Midland.

WHEREAS the Council of the Corporation of the Town of Midland passed Zoning Bylaw 2004-90, known as the Zoning By-law, on the 22nd day of November 2004, to regulate the development and use of lands within the Town of Midland; and,

AND WHEREAS the Council of The Corporation of the Town of Midland has received an application to Amend Zoning By-law 2004-90 and has approved the Application; and,

**AND WHEREAS** the Council of The Corporation of the Town of Midland now deems it expedient to amend Zoning By-law 2004-90, pursuant to the authority given to it under Section 34 of the Planning Act, R.S.O. 1990;


## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MIDLAND HEREBY ENACTS AS FOLLOWS:

- That the lands described as Parts 1 & 2, Registered Plan 51R-45077, in the Town of Midland, County of Simcoe, and having the municipal address of 736 King Street, as shown on Schedule "A" attached hereto shall be subject of this By-law.
- That the lands described above and on Map 37 of Schedule "A" to Zoning Bylaw 2004-90, as amended, and as shown on Schedule "A" attached hereto and forming part of this By-law, shall be rezoned from the "Residential Mobile Home (RM) Zone to the "Highway Commercial (HC)" Zone
- 3. That all provisions of Zoning By-law 2004-90, as amended, except those expressly amended herein shall apply to the subject land.
- That this By-law shall come into force and effect on the final passage thereof.
