## Notice of Completion



### Town of Midland Waterworks Master Plan Update

The Town of Midland initiated an update to the existing Waterworks Services Master Plan (2013) to reflect growth in the community, planned development, and operational changes and to generally provide a comprehensive water servicing infrastructure plan for the community for the next 20 years. Following the completion of two Public Information Centres and the receipt of input from interested parties, the Town of Midland has completed the update and selected the Preferred Strategy to address water servicing deficiencies in the community.

The following projects form part of the Recommended Strategy and will be implemented using a phased approach. For a complete list of projects please refer to the Water Servicing Master Plan document available on the Town's website:

- Short Term Projects (1-5 years) include upgrades to the Everton Booster Pump Station (Alt. 3C), abandonment of Well 12 & Well 1A (Alt. 2A), and the twinning of the Harbourview Drive Watermain (Alt. 5A) (all Schedule A/A+) and upgrades to the Hanly St. Booster Pump Station (Alt. 3A) (Schedule B).
- Mid-Term Projects (5-10 years) include the development of a new South Pressure Zone with new Booster Pump Station and associated watermain (Alt. 4A) and new storage in the East Pressure Zone (Alt. 1A) (both Schedule B).
- Long Term Projects (15-20 years) include the decommissioning of the Dominion and Montreal Storage Tanks and a new trunk watermain on Highway 93 for the West Zone (Alt. 4B) (all Schedule A/A+). Schedule B projects include the commissioning of the Sundowner Well (Alt. 2A) and construction of a new Booster Pump Station at Balm Beach Road.

This undertaking was completed in accordance with the *Municipal Class Environmental Assessment (Oct. 2000, as amended 2007, 2011 & 2015)* with the intent of addressing Phases 1 and 2 of the Class EA process (Approach #2) thereby fulfilling the requirements for the Schedule 'A', 'A+', and select 'Schedule B' projects identified within the document. Following the completion of this Master Plan Update the Town may proceed with implementation of the pre-approved Schedule A and A+ projects and the Hanly St. Booster Pump Station upgrades (Schedule B) subject to funding and the receipt of necessary approvals. The identified mid-term and long-term Schedule B projects will require additional study to fulfill MCEA requirements prior to implementation.

By this notice the Waterworks Master Plan Update document is being placed on the public record for a 30-day public review period ending July 30, 2021. Requests on other grounds will not be considered. It is recognized that the connection of the Payette Water System to the Midland Water System is an option that is being explored as part of that Class EA process and that to support the evaluation of this option you would like the Town of Midland keep the potential for the connection of the two water systems available as part of its comprehensive water servicing strategy for the next 20 year period. The connection of the Payette Water System to the Midland Water System is an option that is being explored as part of our MCEA process.


