THE CORPORATION OF THE TOWN OF MIDLAND

BY-LAW 2025-7

As Amended by By-law 2025-43, 2025-64

A By-law to regulate parking within the Town of Midland and to repeal By-law 2024-34

WHEREAS Section 11 (3)(1) and Section 11(4)(3) of the Municipal Act, 2001, S.O, c. 25 allows lower tier municipalities to pass by-laws respecting highways including parking and traffic on highways;

AND WHEREAS Section 102.1 of the Municipal Act, 2001, S.O. c. 25, and O. Reg 333/07 enables a municipality to require a person, subject to such conditions as the municipality considers appropriate, to pay an administrative penalty if the municipality is satisfied that the person has failed to comply with any provision of this by-law respecting the parking, standing or stopping of a vehicle;

AND WHEREAS Section 425 of the Municipal Act, 2001, S.O, c. 25 establishes that any person who contravenes any by-law of the municipality passed under the Act, is guilty of an offence;

AND WHEREAS the Council of the Corporation of the Town of Midland deems it desirable and expedient to pass a by-law to regulate parking in the Town of Midland;

NOW THEREFORE, the Council of the Corporation of the Town of Midland enacts as follows:

This By-law shall be known as the "Parking By-law".

1.0 DEFINITIONS

For the purpose of this By-law, the following definitions shall apply:

- "Accessible Parking Permit" means an accessible parking permit issued by the Ministry of Transportation.
- "Accessible Parking Space" means a designated Parking Space or parking area under this by-law for the exclusive use of a **Vehicle** displaying a permit in accordance with the requirements thereunder and this by-law.
- "Authorized Sign" means a sign or other device placed or erected on a **Highway** or elsewhere pursuant to the provisions of this by-law or approved by the Ministry of Transportation of Ontario for the purpose of regulating, warning or guiding traffic.
- "Bicycle" includes a tricycle and unicycle but does not include a Motor Assisted Bicycle.
- "Boulevard" means a portion of a Highway, paved or unpaved between the Town property line and the Curb Line but does not include the sidewalk or any centre median strip or island separating two (2) Highways.
- "Bus Stop" means that part of a **Highway** designated by a sign where buses will stop to take on or let off passengers.
- "Commercial Motor Vehicle" means a Motor Vehicle having permanently attached thereto a truck or delivery body and includes ambulances, hearses, casket wagons, fire apparatus, buses and tractors used for hailing purposes on a **Highway**.

"Crosswalk" means:

(a) Part of a Highway at an Intersection that is included within the connections of the lateral lines of the sidewalks on opposite sides of the Highway measured from the Curbs, or, in the absence of Curbs, from the edges of the Roadway; or

(b) Any portion of a **Roadway** at an **Intersection** or elsewhere distinctly indicated for pedestrian crossing by **Signs** or by lines or other marking on the surface;

"Curb" means the edge of the Roadway and gutters.

"Curb Line" means the line of the Curb, or, where no Curb is constructed, the edge of the travelled portion of the Highway.

"Damage" means but is not limited to, any action or thing that defaces, conceals, injures, tampers with, breaks, destroys or impairs any Parking Meter, Authorized Sign or any other Traffic Control Signal.

"Designated School Crossing" means a Crosswalk which is established and specifically designated by Signs to facilitate the crossing of a Highway by any Person associated with a school.

"**Driveway**" means improved land on a **Highway** which provides vehicular access from the **Roadway** to a **Laneway** or a parking area on adjacent land.

"Electric Vehicle" means:

- (a) A **Vehicle** that runs only on a battery and an electric drive train, or;
- (b) A plug-in hybrid electric vehicle that runs on a battery and an electric drive train, and also uses an internal combustion engine.

"Electric Vehicle Charging Station" means any facility or equipment that is used to charge a battery or other energy storage device of an Electric Vehicle.

"Electric Vehicle Parking Space" means a parking space designated for the use of charging Electric Vehicles as indicated by a sign.

"Executive Director, Infrastructure Management" means the person holding this title or their designate. For the purposes of this By-law, if this title changes or is renamed, any new title shall be deemed to be the same as this definition.

"Fees and Charges By-law" means the current version of the Town of Midland Fees and Charges By-law.

"Highway" means a common and public Highway, Street, Boulevard, centre, crescent, lane, avenue, parkway, square, place, court, bridge, viaduct or trestle, designed and intended for, or used by the general public for the passage of Vehicles, including unopened and unassumed Highways.

"Intersection" means the area embraced within the prolongation or connection of the lateral **Curb Lines** or, if none, then of the lateral boundary lines of two (2) or more **Highways** that join one another at an angle, whether or not one **Highway** crosses the other.

"Laneway" means improved land adjacent to the **Highway** which provides access from the **Highway** to a parking area on adjacent land.

"Large Vehicle" means any Vehicle having a Vehicle Weight greater than two thousand three hundred (2,300) kilograms (5,060 pounds).

"Local Board" means a Local Board within the meaning of the Municipal Act, 2001.

"Manager of Operations" means the Manager of Operations for the Town of Midland, or their designate.

"Motor Assisted Bicycle" means a Bicycle:

- (a) Fitted with pedals which are operable at all times to propel the **Bicycle**;
- (b) Weighing not more than fifty-five (55) kilograms (120 pounds);
- (c) Which has no hand or foot operated clutch or gearbox driven by the motor and transferring power to the driven wheel;
- (d) Having an attached motor driven by electricity or having a piston displacement of not more than fifty (50) cubic centimetres (3 cubic inches);
- (e) Which does not have sufficient power to enable the **Bicycle** to attain a speed greater than fifty (50) kilometres per hour (30 miles per hour) on level ground within a distance of two (2) kilometres) (1.25 miles) from a standing start.
- **"Municipal Law Enforcement Officer"** means a **Person** appointed by By-law as a Municipal Law Enforcement Officer by the Council of the Corporation of the Town of Midland.
- "Motorcycle" means a self-propelled **Vehicle** having a seat or saddle for the use of the driver and designed to travel on not more than three (3) wheels in contact with the ground and includes a motor scooter, but does not include a **Motor Assisted Bicycle**.
- "Motor Vehicle" means an automobile, Motorcycle, Motor Assisted Bicycle unless otherwise indicated in the *Highway Traffic Act* and any other Vehicle propelled or driven otherwise than by muscular power, but does not include a street car, or other Motor Vehicle running only upon rails, or a motorized snow Vehicle, traction engine, farm tractor, self-propelled implement of husbandry or road-building machine within the meaning of the *Highway Traffic Act*.
- "Municipal Parking Lot" means land or structures which have been set apart, designated or established by the Town for the parking of Motor Vehicles.
- "Occupant" when used in relation to property, means:
 - (a) The tenant of the property or part thereof whose consent shall extend only to the control of the land of which they are a tenant and any **Parking Spaces** allotted to him under his lease or tenancy agreement; or
 - (b) The spouse of a tenant; or
 - (c) A **Person** or the Town of Midland, or a **Local Board** thereof, having an interest in the property under an easement or right of way granted to or expropriated by the **Person**, the **Town** or **Local Board** whose consent shall extend only to the part of the property that is subject to the easement or right of way.
- "Officer" means a **Municipal Law Enforcement Officer** for the Town of Midland, **Police Officer**, or any other **Person** appointed by by-law to carry out the enforcement of this by-law.
- "One-Way Street" means a **Highway** upon which vehicular traffic is limited to movement in one direction.
- "Owner" when used in relation to a **Vehicle** means the last registered name on file with the Ministry of Transportation.

"Owner" when used in relation to property means:

- (a) The registered **Owner** of the property; or
- (b) The registered **Owner** of a condominium unit, whose consent shall extend only to the control of the unit of which they are an **Owner** of and any **Parking Spaces** allotted to them by the condominium corporation or reserved for their exclusive use in the declaration or description of the property; or
- (c) The spouse of a **Person** described in (a) or (b) of this definition; or
- (d) Where the property is included in a description registered under the *Condominium Act, 1998, S.O. 1998, c. 19 (Condominium Act)* the Board of Directors of the Condominium corporation or
- (e) A **Person** authorized by the property **Owner** as defined in this definition to act on the **Owner's** behalf for requesting the enforcement of this by-law.
- "Parking Lot Space" means a portion of the surface of a parking lot normally designated by lines painted or marked on the surface of the parking lot.
- "Park" or "Parking" means when prohibited, the Standing of a Vehicle, whether occupied or not, except when Standing temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers.
- "Parkland" means any and all land owned by or made available by lease, agreement or otherwise to the **Town** that:
 - (a) Has been or hereafter may be set apart, designated, dedicated or established by the **Town** as a public park, including the water areas, piers and shoreline of such property; or
 - (b) Is maintained by the **Town** as a **Boulevard**, median, landscaped buffer area or walkway; or
 - (c) Any area of land that can be utilized as a sports playing area such as but not limited to: soccer fields, baseball diamonds, pickleball courts, tennis courts, basketball courts.
- "Parking Meter" means an electronic or mechanical device, with the necessary standard for same, for the purpose of controlling and regulating the parking of any Vehicle in a Parking Space and measuring and recording the duration of such parking for a specified fee.
- "Parking Machine" means a mechanical or electronic device which is designed to receive coin or other payment, and which may produce a receipt authorizing a **Vehicle** to remain parked in a designated **Parking Space** for a period of time not to exceed the expiration time specified on the display or receipt.

"Parking Space" means:

- (a) A portion of the surface of the travelled portion of a **Highway** or of the **Shoulder** forming part of a **Highway**, designated by suitable markings, the use of which for parking **Vehicles** is controlled and regulated by a parking meter and/or designated for angle parking only; or
- (b) On **Private Property** an area designated by suitable markings, the use of which for parking **Vehicles** may be controlled and regulated by a parking meter and/or designated for angle parking only.
- "Private Property" means any land owned by individuals or corporations other than the Town.

"Public Transit Vehicle" means a Motor Vehicle owned by or operated by the Town, County of Simcoe or provincial authority which is designed for carrying ten (10) or more passengers and used solely for the transportation of **Persons** upon payment of a prescribed fee.

- "Person" means any human being, firm, association, partnership, private club, incorporated company, corporation, tenants in common, joint tenants, agent or trustee and the heirs, executors or other legal representatives of a **Person** to whom the context can apply according to law and for the purpose of this by-law includes the **Owner** or driver of a **Vehicle**.
- "Police Officer" means a Police Officer appointed pursuant to subsection 15(1) of the Police Services Act, R.S.O. 1990, c. P. 15 and amendments thereto.
- "Residential Zone" means any highway in the municipality where properties on both or either side of the highway are zoned under any type of residential zone within the Town's current Zoning By-law.
- "Roadway" means that part of the Highway that is improved, designed or ordinarily used for vehicular traffic, but does not include the **Shoulder**, and, where a **Highway** includes two (2) or more separate **Roadways**, the term "**Roadway**" refers to any one **Roadway** separately and not to all of the **Roadways** collectively.
- "Shoulder" means that part of the **Highway** immediately adjacent to the **Roadway** and having a surface which has been improved with asphalt, concrete or gravel for the use of **Vehicles**.
- "Sidewalk" means that portion of a **Highway** as is set aside by the **Town** for the use of pedestrians.
- "Significant Weather Event" means a period of time during which the Executive Director, Infrastructure Management declares that there is an anticipation of snow fall or accumulation which is likely to require extensive snow ploughing, snow clearing, or snow removal operations. A Significant Weather Event shall be in effect until the Town deems it appropriate to end the event.
- "Stand" or "Standing" when prohibited, means the halting of a Vehicle, whether occupied or not, except for the purpose of and while actually engaged in receiving or discharging passengers.
- "Stop" or "Stopping" when prohibited, means the halting of a Vehicle, even momentarily, whether occupied or not, except when necessary to avoid conflict with other traffic or in compliance with the directions of a Police Officer or of a traffic control sign or signal.
- "Street" means a common and public **Highway**, **Street**, **Boulevard**, centre, crescent, lane, avenue, parkway, square, place, court, bridge, viaduct or trestle, designed and intended for, or used by the general public for the passage of **Vehicles**, including unopened and unassumed **Highways**.
- "Signs" mean any sign or other device erected or placed on a **Highway**, private or **Town** property for the purpose of regulating or guiding traffic.
- "**Taxicab Stand**" means the area designated by the **Town** to be used by a taxicab while waiting for or picking up goods or passengers.
- "Town" means The Corporation of the Town of Midland.
- "Traffic Signal or Traffic Control Signal" means any device manually, electrically or mechanically operated for the regulation of traffic.
- "Trailer" means the same as defined within the Highway Traffic Act.

"Vehicle" means a Motor Vehicle, Trailer, traction engine, farm tractor, road-building machine, Bicycle and any Vehicle drawn, propelled or driven by any kind of power, including muscular power, but does not include a motorized snow Vehicle or a street car.

"Vehicle Weight" means the weight of the Vehicle itself, as set out in the manufacturer's specifications.

2.0 WORD USAGE

- 2.1 As used in this by-law, words used in the present tense include the future, words used in the masculine gender include the feminine and neutral; and the singular number includes the plural and the plural the singular.
- 2.2 The headings and subheadings used in this by-law shall not form a part of the by-law but shall be deemed to be inserted for convenience of reference only.

3.0 EXPRESSION OF TIME

3.1 Where, in this by-law, any expression of time occurs or when any hour or other point of time is stated, the time referred to or intended shall be reckoned as standard time except in periods when daylight saving time is declared to be in effect, then, during such periods, the time referred to or intended shall be reckoned as daylight saving time.

4.0 INTERPRETATION

4.1 Where there is any conflict between the provisions of this by-law and the provisions of the *Highway Traffic Act*, the provisions of the *Highway Traffic Act* shall prevail to the extent of the conflict.

5.0 GENERAL PROVISIONS

- 5.1 An **Officer** or the **Manager of Operations** are hereby authorized to place or erect and maintain any permanent or temporary **Authorized Signs** on any **Highway**.
- 5.2 This by-law may be enforced by an **Officer** or their designate.
- 5.3 The Schedules to this by-law shall form part of this by-law.
- 5.4 The Schedules attached to this by-law may be amended from time to time by a resolution of Council.

6.0 EXEMPTIONS

- 6.1 The provisions of this by-law shall not apply to:
 - (a) Ambulances, Police, Fire Department, or public utility emergency **Vehicles**; or
 - (b) **Vehicles** of the **Town** or **Vehicles** contracted by the **Town** where such **Vehicles** are engaged in the performance of their respective duties; or
 - (c) Any **Vehicles** while engaged in works undertaken for or on behalf of the **Town**, The County of Simcoe, or the federal or provincial government; or
 - (d) **Public Transit Vehicles** where compliance would be impractical due to the placement of **Bus Stops**.

7.0 METHOD OF PARKING

7.1 No **Person** shall **Park** or **Stop** a **Vehicle** on any **Highway** unless on the right side of the **Highway**, having regard to the direction in which the **Vehicle** had been

proceeding, with the right front or right rear wheels or runners not more than 0.15 metres (15 centimetres) from the **Curb** or boundary of the **Highway** as near this as the condition of the **Highways** permit. This provision shall not apply to prevent the **Parking** of a **Vehicle** on the left side of a **One-Way Street**, nor to prevent the angle **Parking** of **Vehicles** on **Highways** or sections of **Highways** where angle **Parking** is permitted.

- 7.2 On **Highways** or parts of **Highways** where angle **Parking** is permitted, no **Person** shall **Park** a **Vehicle** except at the angle indicated by authorized markings or **Signs** and so the front end of the **Vehicle** is nearest the edge of the **Roadway** except where the angled **Parking** is 90 degrees/perpendicular to the **Roadway**.
- 7.3 Where **Parking** is permitted on a **One-Way Street**, a **Person** may **Park** a **Vehicle** facing only in the direction in which the **Street** allows and parallel to and with the wheels not more than 0.15 metres (15 centimetres) from either edge of the **Roadway** or where the **Curbs** exist from either **Curb**.

8.0 PARKING PROHIBITED IN SPECIFIED PLACES

- 8.1 No **Person** shall **Park** any **Vehicle** or any part of a **Vehicle**:
 - (a) On or over a Sidewalk;
 - (b) On any portion of a Boulevard;
 - (c) Within an Intersection;
 - (d) Within nine (9) metres (30 feet) of an Intersection;
 - (e) Within any portion of a Crosswalk;
 - (f) Within three (3) metres (10 feet) of a point on the **Curb** or edge of a **Roadway** opposite a fire hydrant;
 - (g) In front of or within one (1) metre of any portion of a public or private **Driveway** or **Laneway**;
 - (h) On any **Roadway** or **Highway** having an overall width of less than six (6) metres (20 feet);
 - (i) In such a manner as to obstruct traffic;
 - (j) On any **Highway** for a period longer than six (6) hours;
 - (k) On any **Highway** for a period longer than two (2) hours within the boundary limits listed in Schedule "B";
 - (I) In such a position that will prevent the convenient removal of any other **Vehicle** previously parked or left **Standing**;
 - (m) Where **Parking** spaces are designated by lines painted on the **Roadway**, **Park** a **Vehicle** that is not completely within a single **Parking** space;
 - (n) Within any municipal **Parkland** in an area not specified for **Parking**;
 - (o) Within an Electric Vehicle Parking Space where such vehicle is not an Electric Vehicle;
 - (p) Within an Electric Vehicle Parking Space where such Vehicle is not connected to an Electric Vehicle Charging Station and charging.

9.0 PARKING OR STOPPING PROHIBITED IN SPECIFIED PLACES WHERE SIGNS ARE DISPLAYED

- 9.1 Where appropriate **Signs** have been erected and are on display, no **Person** shall at any time **Park** a **Vehicle**:
 - (a) Within fifteen (15) metres (50 feet) of an Intersection;
 - (b) Within fifteen (15) metres (50 feet) of a **Designated School Crossing**;
 - (c) On any of the **Streets**, parts of **Streets** or sides of **Streets** named or described in Schedule "C" of this By-law;
 - (d) Within fifteen (15) metres (50 feet) of a Crosswalk; or
 - (e) Other than a bus, within any bus loading and unloading zone;
- 9.2 Where appropriate **Signs** have been erected and are on display, no **Person** shall **Stop** any **Vehicle**:
 - (a) Within fifteen (15) metres (50 feet) of an **Intersection**;
 - (b) Within fifteen (15) metres (50 feet) of a **Designated School Crossing**;
 - (c) On any of the **Streets**, parts of **Streets** or sides of **Streets** named or described in Schedule "D" of this By-law; or
 - (d) Within fifteen (15) metres (50 feet) of a Crosswalk.
- 9.3 No **Person** shall **Park** a **Vehicle** other than a taxicab in a **Taxicab Stand** when and such **Stop** or **Stand** has been signed. This provision shall not apply to any driver of a **Vehicle** who is actively loading or unloading passengers where such action does not interfere with any taxicabs waiting to enter or exit such area.

10.0 TIME LIMIT PARKING

10.1 Where appropriate **Signs** are displayed, no **Person** shall **Park** a **Vehicle** on any **Highway** or within any **Municipal Parking Lot**, within the limits set out in Column 2 of Schedule "E" attached to this by-law, during the times or days set out in Column 4 of Schedule "E" for a longer period of time than set out within Column 3 of Schedule "E".

11.0 PARKING OR STANDING INTERFERING WITH SNOW REMOVAL AND DURING WINTER SEASON

- 11.1 Notwithstanding any other provision of this by-law which permits the **Parking** of **Vehicles** on **Highways** or within any **Municipal Parking Lot**, no **Person** shall **Park**, **Stop** or **Stand** a **Vehicle** in such a manner as to interfere with the clearing of snow from a **Highway** or **Municipal Parking Lot**.
- 11.2 No **Person** shall **Park** any **Vehicle** on any **Highway** or within any **Municipal Parking Lot,** between the hours of 12:01 a.m. and 7:00 a.m. between November 15th in any year until April 1st of the following year.
- 11.3 Notwithstanding any other section in this by-law, no **Person** shall park on any highway within the municipality during a **Significant Weather Event**.
- 11.4 The **Town** shall ensure that notice to the public of a **Significant Weather Event** or an extension thereof is given in at least two of the following means:
 - (a) The issuance of a media advisory

- (b) Posting notification on the **Town's** website; or
- (c) Any other means of giving notice that has a reasonable likelihood of coming to the attention of persons who are affected.

12.0 PARKING IN RESIDENTIAL ZONES

- 12.1 No **Person** shall **Park** a **Large Vehicle** on any **Street** within any **Residential Zone** unless it is being used to make a delivery or to provide a service.
- 12.2 No **Person** shall **Park** a detached **Trailer** on any **Street** within any **Residential Zone**.

13.0 PARKING ON PRIVATE PROPERTY

- 13.1 The property **Owner** or authorized agent may provide to the municipality, a letter authorizing the enforcement of this by-law on **Private Property** by **Officers** of the municipality. Where a letter of authorization has been filed with the municipality, an **Officer** shall be deemed to have the authority to enter onto the **Private Property** to enforce the provisions of this by-law at any time.
 - (a) In addition to a letter of authorization, the property **Owner** or authorized agent shall provide a site map of the property to scale which includes but not limited to:
 - (i) All parking spaces including **Accessible Parking Spaces** and any designated spaces;
 - (ii) All buildings and other structures located on the property;
 - (iii) All fire routes located on the property (if applicable).

13.2 No **Person** shall **Park** or leave a **Vehicle**:

- (a) On **Private Property** without the consent of the **Owner** or **Occupant** of the property;
- (b) On property owned or occupied by a public authority or any **Local Board** without the consent of the public authority or **Local Board**, as the case may be;
- (c) If a parking space has been designated by lines painted on the surface of the parking area on **Private Property**, no **Person** shall **Park** any **Vehicle** in such a manner that is not wholly within the area designated as a **Parking Lot Space**.
- 13.3 Where **Signs** have been posted, stating conditions on which a **Vehicle** may be parked or left on the property, or prohibiting the **Parking** or leaving of a **Vehicle** on the property, a **Vehicle** parked or left on the property contrary to such conditions or prohibitions shall be deemed to have been parked or left without consent.

14.0 ACCESSIBLE PARKING PROVISIONS

- 14.1 No **Person** shall **Park** or cause to be parked a **Vehicle** within a parking space designated as an **Accessible Parking Space** on municipally owned property or privately owned property without displaying a valid **Accessible Parking Permit** issued by the Ministry of Transportation.
 - (a) For the purposes of Section 14.1, an **Accessible Parking Permit** shall be clearly displayed with the permit number and expiry date visible on the **Vehicle's** sun visor in which is turned down or the dashboard.

15.0 TAXI CAB STANDS

15.1 A taxi cab operator who is licensed to operate within the **Town**, may contract with the **Town**, to reserve a maximum of three (3) parking spaces for taxi cabs for a fee as set out in the **Fees and Charges By-law**;

15.2 The **Town** shall post a sign reading "Taxi Parking Only" on any parking space when it has rented to a taxi cab operator as a reserved taxi cab parking space.

MUNICIPAL PARKING LOTS

16.0 SIGNS AND MARKERS

- 16.1 The **Town** is authorized to erect in or on any **Municipal Parking Lot** such gates, attendant shelters, **Signs** and markers or other devices as may be necessary for the safe and efficient operation of such **Municipal Parking Lot**.
- 16.2 The **Town** shall cause the amount of the fee for **Parking** to be clearly displayed in a conspicuous place in or on each **Municipal Parking Lot** by means of a sign.

17.0 PROHIBITIONS

- 17.1 No Person shall Park any Large Vehicle in or on any Municipal Parking Lot.
- 17.2 No **Person** shall use any **Municipal Parking Lot**:
 - (a) For the purpose of **Parking** a **Vehicle** while repairs are being made to such **Vehicle**, unless such repairs are of an emergency nature and are required to be made so that the **Vehicle** can be moved from the **Municipal Parking Lot**;
 - (b) For the purpose of storing or keeping a **Vehicle** or **Vehicles**;
 - (c) For any purpose other than **Parking** purposes, unless permission to do so is granted by the **Town**;
 - (d) To Park a detached Trailer of any kind in a Municipal Parking Lot;
 - (e) To Park a bus in a Municipal Parking Lot;
 - (f) To **Park** any **Vehicle** or **Trailer** overnight from 11:00 p.m. of one day to 7:00 a.m. of the next day.
- 17.3 No **Person** shall **Park** or leave any **Vehicle** in or on any part of a **Municipal Parking Lot** where, by means of one (1) or more **Signs**, it is indicated that such **Parking** is not authorized.
- 17.4 No Person shall Damage any Parking Meter, Parking Machine, Authorized Sign or any other Traffic Control Signal.
- 17.5 If a **Parking Space** has been designated by lines painted on the surface of the **Municipal Parking Lot**, no **Person** shall **Park** any **Vehicle** in such a manner that is not wholly within the area designated as a **Parking Lot Space**.
- 17.6 No **Person** shall park any **Vehicle** in an aisle, laneway, or pathway in a **Municipal Parking Lot**.

18.0 PETE PETTERSEN BOAT LAUNCH

18.1 The land as identified within the green shaded area labelled "Boat Launch Parking with Trailer" within Schedule "F" is hereby designated as a paid parking area.

18.2 No **Person** shall **Park** any **Vehicle** within the green shaded area labelled "Boat Launch Parking with Trailer" within Schedule "F" without a valid permit by paying the appropriate fee as set out in the Town of Midland **Fees and Charges By-law**.

- 18.3 No **Person** shall **Park** any **Vehicle** without a **Trailer** attached within the green shaded area and labelled "Boat Launch Parking with Trailer" within Schedule "F".
- 18.4 No **Person** shall **Park** a **Vehicle** with a **Trailer** within the purple shaded area labelled "FREE Vehicle Parking" within Schedule "F" at anytime.

19.0 OFFENCES AND PENALTIES

- 19.1 Every **Person** who contravenes any provision of this By-law is guilty of an offence and on conviction is liable to a fine as provided for in the Provincial Offences Act, R.S.O. 1990, c. P.33.
- 19.2 Every **Person** who contravenes any section of this By-law shall, upon issuance of a penalty notice in accordance with the **Town's** Administrative Monetary Penalty System By-law, be liable to pay the **Town** an Administrative Monetary Penalty.
- 19.3 In addition to any other penalties provided by this By-law, upon discovery of any **Vehicle** parked, or stopped on any **Highway**, or parked or left in an unauthorized area on **Town** property, in contravention of any provision of this by-law, the **Manager of Operations** or an **Officer** appointed for the carrying out of the provisions of this By-law or the *Highway Traffic Act* may cause such **Vehicle** to be moved or taken to and placed or stored in a suitable place and all costs and charges for the removing, care and storage thereof, if any, are a lien upon the **Vehicle** being released and may be enforced in the manner provided by the *Repair and Storage Liens Act, R.S.O. 1990, c. 25 as amended*.

20.0 VALIDITY AND SEVERABILITY

20.1 If any court of competent jurisdiction finds that any of the provisions of this By-law are ultra vires the jurisdiction of Council, or are invalid for a reason, such provision shall be deemed to be severable and shall not invalidate any of the other provisions of the By- law which shall remain in full force and effect.

21.0 REPEAL OF FORMER BY-LAW

21.1 By-law 2024-34 is hereby repealed.

22.0 TRANSITION

22.1 The repeal of by-laws referred to in Section 21.1 shall not affect any offence committed against the provisions of the by-law or any penalty incurred in respect thereof or any investigative procedure, including but not limited to any prosecution thereunder.

23.0 EFFECTIVE DATE

23.1 This by-law shall come into force and take effect on March 1st, 2025.
